Request For Postponement Of The Preliminary Determinations**

Dear Secretary Raimondo:

On behalf of Cleveland-Cliffs Inc. and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union (“Petitioners”), we request, pursuant to 19 C.F.R. § 351.205(e), that Commerce postpone the preliminary determinations in the above-referenced antidumping investigations. Postponement is warranted so that Commerce can evaluate fully the initial questionnaire responses submitted by the mandatory respondents and solicit supplemental information as necessary. In addition, Petitioners seek postponement of all the antidumping investigations in order to keep them on the same schedule and avoid the need to split the cases at the International Trade Commission.
