This questionnaire was formulated by the Ministry of Commerce of the People's Republic of China in accordance with the provisions of the Anti-Dumping Regulations of the People's Republic of China for the purpose of investigating and adjudicating whether the anti-dumping measures applicable to imports of phenol originating in the United States, the European Union, South Korea, Japan and Thailand may lead to continued or recurrence of dumping and damage.

This case was investigated for imports of phenol originating in the United States, the European Union, Korea, Japan and Thailand. The scope of the review investigation product is the product applicable to the original anti-dumping measures, consistent with the product scope in the Ministry of Commerce's Announcement No. 37 of 2019, which is attributed to the Customs Import and Export Tax of the People's

II. Responsibility to Specific Requests

In exceptional circumstances, and with the consent of the Ministry of Commerce, the interested party may refrain from submitting a non-confidential summary of specific confidential information, but must still submit a reasonable and sufficient written statement stating, item by item, the reasons why the confidential information cannot be summarized.

Methods for providing non-confidential summaries include, but are not limited to, indexing data or indicating data intervals, summarizing and generalizing textual information.

The Ministry of Commerce will review non-confidential summaries provided by stakeholders, who may comment on non-confidential summaries. If it fails to reasonably reflect the substance of the confidential information or lacks a reasonable and sufficient reason

for not being able to summarize, the Ministry of Commerce will inform the interested party of the deadline to correct it once.

If the Ministry of Commerce considers that the stakeholder's application for confidentiality is not justified and the interested party is unwilling to disclose information or authorize disclosure of information in summary form, the Ministry of Commerce may refrain from using such information at the time of its ruling.

3 In accordance with the above principles, the questionnaire should be submitted in a confidential and public version at the same time.
