Notice No.42 (2024)

In accordance with the *Anti-Dumping Regulation of the People's Republic of China*, on 29 August 2024, the Ministry of Commerce released the Notice No. 35 [2024], maintaining that the imported brandy originating in the EU is subject to dumping, and the domestic brandy industry is threatened with substantial injury, and there is a causal relationship between the dumping and the threats of substantial injury.

1. Levying of cash deposit

The Investigation Authority decides to carry out preliminary anti-dumping measures by levying deposit according to Article 28 and Article 29 of the *Anti-dumping Regulations*. As of 11 October 2024, import operators shall pay relevant deposit to the Customs of the People's Republic of China at the rate determined by this ruling for each company when importing the Product under Investigation.

Description of the product under investigation:

spirits obtained by distilling grape wine in containers holding less than 200 liters originating in the EU

Name of the product under investigation:

spirits obtained by distilling grape wine in containers holding less than 200 liters (usually called Brandy)

Product description: strong wine made from grapes, grape juice (pulp), grape skin residue, wine, etc.

Main uses: mainly used as beverage wine for human consumption.

The product is listed under HS codes listed in the *Customs Import and Export Tariff of the People's Republic of China*: 22082000. Spirits obtained by distilling grape wine in containers holding equal to or more than 200 liters under this tariff numbers are not within the scope of this investigation.

2. Methods to Levy Deposit

As of 11 October 2024, import operators shall pay relevant deposit to the Customs of the People's Republic of China according to the dumping margin determined by this ruling for each company when importing brandy originating in the EU. The deposit is levied by means of ad valorem on the basis of dutiable value authorized by China Customs, and the formula is: deposit= (dutiable value authorized by the Customs * levying rate)* (1 + import value-added tax rate).
