Notice on Application for a Hearing of the Safeguards Investigation of Beef

Interested parties,

On 27 December 2024, the Ministry of Commerce of the People's Republic of China released the Notice No.60 [2024] and decided to initiate a safeguards investigation of imports of beef.

In order to ensure the fairness, impartiality and transparency of the investigation process, any interested party may apply for a hearing in accordance with Article 12 of the *Regulations on Safeguard Measures of the People's Republic of China* and the relevant provisions of the Ministry of Commerce's *Interim Rules for Hearings on Safeguard Measures Investigations*. The relevant matters are hereby notified as follows

The interested parties who apply for a hearing shall submit the "Registration Form for Application for Hearing of Safeguards Measures on Beef" (see attachment) to the Trade Remedy Investigation Bureau of the Ministry of Commerce within 20 days from the date of issuance of this Notice. The relevant interested parties shall submit the electronic version of the registration form through the "Trade Remedy Investigation Information Platform" (<http://etrb.mofcom.gov.cn>) and submit the paper version at the same time according to the requirements of the Ministry of Commerce. The electronic version and the paper version shall have the same content and format. Taking into account the investigation time limit, if the interested parties fail to submit an application to the Ministry of Commerce within the time specified in this Notice, the Ministry of Commerce will no longer accept their application for a hearing.

1. This notice and registration form are published on the sub-site of Trade Remedy Investigation Bureau of the Ministry of Commerce of the People's Republic of China (<http://trb.mofcom.gov.cn>). Interested parties may download them directly.
2. The Ministry of Commerce will consider, determine and publish the hearing date and other related matters on the above website.
