Questionnaire Instructions and Answer Requirements

I. General requirements and instructions

1. This questionnaire is prepared by the Ministry of Commerce of the People's Republic of China in accordance with the provisions of the Regulations of the People's Republic of China on Safeguard Measures. The information collected in this questionnaire will be used for the investigation and adjudication of this case. If there is no special explanation, please provide relevant information during the investigation period.

Name of the product under investigation: beef.

English name: Meat of bovine animals

Product Description: The products under investigation are beef products obtained from the slaughter of live cattle (Bos genus), including fresh, chilled or frozen whole and half-head beef, bone-in beef and boneless beef.

This product is classified in the Customs Import and Export Tariff of the People's Republic of China: 02011000, 02012000, 02013000, 02021000, 02022000, 02023000.

The scope of the products under investigation is based on the above description, and the tariff number is for reference only.

2. This investigation will be completed within 8 months from the date of filing the case, and may be extended appropriately under special circumstances.

3. The investigation period of this case is from January 1, 2019 to June 30, 2024. Except for the parts with special instructions in this questionnaire, "year" refers to the natural year.

4. Your company should provide all the information required by this questionnaire and submit a complete and accurate answer sheet within the specified time so that the Trade Remedy Investigation Bureau of the Ministry of Commerce can analyze and make a ruling on your company's response as soon as possible. Your company's **full cooperation during the investigation** will play an important role in the investigation of the case.

5. When the Ministry of Commerce conducts an investigation, the interested parties shall truthfully reflect the situation and provide relevant information. Any information provided by the interested parties shall be in standard Chinese. Non-Chinese information shall be submitted in Chinese translation and original text, and the Chinese translation shall prevail. If the interested parties fail to truthfully reflect the situation, provide relevant information, or fail to provide necessary information within a reasonable time, or seriously hinder the investigation in other ways, the Ministry of Commerce may make a ruling based on the facts already obtained and the best information available.

6. If your company has any questions about the questionnaire while answering the questionnaire, you can consult the case investigators listed in the questionnaire in written form.
